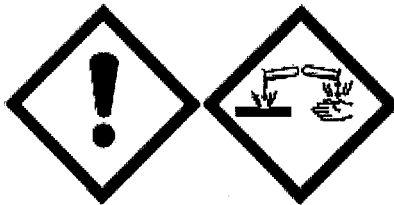

General advice
